Puppy Raiser Dog Adoption Agreement

This is the Agreement between The Seeing Eye and the Puppy Raiser Adopter of an Adoptable, a dog which has been removed from The Seeing Eye's training program.

The Puppy Raiser Adopter agrees:

1. To provide adequate and proper nutrition, care, attention and living accommodations for the Adoptable, including regular veterinary care and vaccinations.
2. To observe all applicable state and local registration, animal control and anti-cruelty laws and regulations.
3. That the Puppy Raiser Adopter has been given the opportunity to examine and visit with the Adoptable, and accepts the Adoptable as is, without reservation or conditions of any kind.
4. To keep the Adoptable and not give it away.
5. To provide The Seeing Eye access to the Adoptable for purposes of examination and/or blood collection when requested.

The Puppy Raiser Adopter acknowledges that The Seeing Eye, its Trustees, Officers, Employees, and Volunteers have made no commitments or guarantees of any kind as to the temperament, health, intelligence, personality, or suitability for adoption of any Adoptable. The actions of dogs can be unpredictable, and their behavior may be different in a new environment from what it was at The Seeing Eye's kennels. Dogs must be closely supervised when interacting with other animals and people, especially children.

The Puppy Raiser Adopter agrees to release and waive any claim he/she may now or in the future have, and to indemnify and hold harmless The Seeing Eye, Inc., its Trustees, Officers, Employees, and Volunteers with respect to the claim of anyone for loss or damage to property or injury to person, or violation of any law or regulation, concerning the condition or behavior of the Adoptable.

The Puppy Raiser Adopter assumes absolute ownership of the Adoptable upon the signing of this Agreement, and The Seeing Eye has no right or obligation to reacquire the Adoptable for any reason. Nevertheless, if due to unforeseen circumstances the Adopter is unable to provide the Adoptable with a good home, upon the request of the Puppy Raiser Adopter within thirty days from the date hereof The Seeing Eye will consider taking the Adoptable back, although it has no obligation to do so.

The Puppy Raiser Adopter is at least eighteen years of age, has read this Agreement, and agrees to be bound by its provisions.
